NSBC Training Programs Grow

The National Safe Boating Council's (NSBC) training programs are growing by leaps and bounds! Currently, the NSBC has two training programs, the Boating Safety Instructor Training Course and the Close Quarters Boat Control Course. The NSBC is in the process of developing a third, the Open Water Boat Control Course.

The Boating Safety Instructor Training Course partners with the National Association of State Boating Law Administrators (NASBLA) and focuses on the NASBLA standards by providing the proper interpretation of each standard for instructors who will be teaching course content to recreational boaters nationwide. Twenty candidates were certified in 2012.

The Close-Quarters Boat Control Course focuses on maneuvers and techniques used for basic boat handling in close quarters. The curriculum is presented in an easy step-by-step process. During 2012, the NSBC certified 173 instructors and 10 instructor trainers.

The Open Water Boat Control Course is being developed and will begin the instructor implementation phase in 2013. The Open Water Boat Control Course will follow the same step-by-step process and will focus on maneuvers and techniques used while cruising on a lake.

Hall of Fame

The National Safe Boating Council inducted two new members into the Boating Safety Hall of Fame, Ruth Wood and John Johnson. Ms. Wood was instrumental in building BoatU.S. Foundation's national reputation as a leader in boating safety and environmental stewardship. Ms. Wood's dedication to recreational boating has contributed to the improvement of life jacket design and awareness, online education and responsible boating. During her outstanding 28-year career, Ms. Wood has been recognized for her dedication to boating safety by the National Association of State Boating Law Administrators, the United States Coast Guard and the British Sub-Agua Club. John Johnson started his career in the safe boating arena in 1992 at the Center for Recreational Safety in Lexington, Kentucky, serving as an administrative contractor first with the National Safe Boating Council and ultimately with the National Association of State Boating Law Administrators (NASBLA). As the Executive Director of NASBLA, Mr. Johnson has guided NASBLA's growth and prominence as the nation's leading association for boating





program administrators and safe boating initiatives in the 56 states and U.S. Territories. He was instrumental in developing outreach and intra-operative agreements, organizational activities and relationships in the name of furthering boating safety.

The DVD was chosen as a winner in the Non-Telecast Non-Fiction Division under the subcategory of "Business – Safety, Training, & Employee Development."

Boating Safety Youth Program Award

BoatU.S. Foundation, patron level member of NSBC, sponsors the Boating Safety Youth Program Award. The program provides a vehicle to recognize individuals and organizations that have developed and successfully implemented innovative boating education programs directed at youth. The 2012 winner is the Raleigh Sail and **Power Squadron** for the sailing program they developed for kids. The program is much more than just a sailing program. The participants in the program actually build their own Optimist prams and then get to keep them. This unique experience, which takes a child through the construction phase all the way through racing, should build a lifelong bond between the child and boating.



OMC Award

The National Safe Boating Council's "Take 'Em Boating" Grant was developed to promote and cultivate an interest in boating for future generations. The Grant is funded by The Outboard Marine Corporation (OMC) Foundation. The 2012 winner is the Mississippi River Water Trail Association for their program "The Mississippi River Water Trail - Nature Is Only a Paddle Away." The Mississippi River Water Trail Association partnered with the U.S. Army Corps of Engineers and other organizations to develop a water trail along the Mississippi River within the St. Louis District boundary. Day use rest areas, primitive camping areas, watchable wildlife and interpretive opportunities on the Mississippi River have been built. The goal is to have a water trail that goes up and down the Mississippi that can be used as a platform to train boaters in a safe and environmentally friendly way.



Congressional Reception

The National Safe Boating Council (NSBC) and the National Association of State Boating Law Administrators hosted the 11th annual Congressional Reception on Tuesday, May 15, in the Gold Room of the Rayburn House Office Building. The Congressional Reception celebrated the approaching National Safe Boating Week and announced the recipients of the 2012 Confluence Awards. The 2012 recipients include Representative Frank LoBiondo (NJ), Representative John Mica (FL), Senator Ben Cardin (MD) and Senator Jay Rockefeller (WV). Through their positions of prestige and responsibility, these individuals have fought for funding, legislation, programs, laws, and regulations for boating safety.

NSBC's 2012 'Wear It!' Campaign Achieves Best

The National Safe Boating Council's 2012 public relation's efforts to promote the North American Safe Boating Campaign exceeded all metrics, reaching a larger audience of boaters about the importance of life jacket wear and boating safety since the campaign was branded as "Wear It!" over a decade ago. Several strategies, including media relations and social media outreach, were used to communicate "Wear It!" throughout North America.

PR Results To Date

"Wear It!" resulted in more than 2,000

earned story placements nationwide (a 36 percent increase compared to 2011) and reached a potential audience of nearly 670 million (a 64 percent increase compared to 2011).

"Ready, Set, Wear It!" – Turning an Idea into a Mission



Boating enthusiasts once again blew away the world record for life jacket wear in 2012. During the third annual "Ready, Set, Wear It!" event held on May 19, 2012, 3,993 people (and pets!) gathered at more than 145 events around the world to set a new world record for the number of participants who inflated their inflatable life jacket or wore an inherently buoyant life jacket.

The success of "Ready, Set, Wear It!" depends on local sponsors and partners. Leland, Ltd. and iSi Components worked with the NSBC to offer over 1,000 CO2 cartridges to allow participants the opportunity to inflate their life jacket, but also practice re-arming techniques of inflatable life jackets. Marine retail sponsors Cabela's and West Marine offered their locations for event organizers throughout the country.

On Saturday, May 18, 2013, we're asking boating safety educators and partner organizations to organize an event in their community. Boaters will gather across the world to inflate their own inflatable life jacket or to wear an inherently buoyant life jacket, helping to heighten awareness of different life jacket types and boating safety issues and go for a world's record along the way. The Opening Reception provided the exhibitors the opportunity to showcase the programs and tools that are available to help promote boating and water safety. The Sea Scouts received special recognition for their 100th Anniversary and Captain Mark Rizzo and Mr. John Malatak were recognized on their retirements from the U.S. Coast Guard for service to their country and the boating community. The objectives and strategies of the Strategic Plan of the National Recreational Boating Safety Program were explained and demonstrated during the "Day at the Beach" event. The Summit concluded the conference with the awards banquet which recognized outstanding organizations and individuals for their work to improve boating and water safety.
